【Course Description】

This course explores modern Japanese cultural imagination by first examining Japan's interactions with the West after Meiji, its psychological novels, and the rise of "naturalist literature" since the turn of the century. It will examine Japan's interactions with ideologies, and its multi-faceted experiments with interwar liberalism. We will assess resistance against fascist totalitarianism in war years and the political culture of Japanese colonialism. The study continues with Japan's postwar conditions through the Korean and Vietnam wars until Mishima Yukio's suicide in 1970.

【Class Goals】

From transnational perspectives, this course is designed to achieve a critical and broad-ranging understanding of the essential elements embodied within, and characteristic of, Japanese literary and cultural modernity from the end of the Edo period in the mid-nineteenth century through the first part of the twentieth century, the interwar and war years, before going into the postwar decades.
